### LOBSTER BALL MACHINE

Please note if you are using the ball machine :

When the flashing lights come on to notify that the battery is getting low it is time to turn it off. DO NOT LET THE BATTERY TOTALLY RUN OUT!! Our current charger is not strong enough to recharge a totally dead battery. Also, please make sure machine is turned off when you put it away. Please make sure you have always turned out the lights in the shed and always lock the door of the shed when you're done. If these things are not done we will have to have a signup sheet to use the ball machine and that is not as convenient for anyone.

### **COURT MAINTENANCE**

Trees are a health and safety issue. HOA should take care of cutting down the trees and replacing them with trees that don't shed onto the court but will still shade them. Jim Ertz will follow up on this. Craig Simmons is also writing a letter to the HOA.
